#### **COVID-19 Response/Improvements:**

Implemented numerous new COVID safety features at city facilities:

- Hand sanitizer stations

- Installed indoor air sterilization systems.

For the last 30 years, Irvine has achieved the "Tree City USA" designation from the Arbor Day Foundation. Achieving this award ensures Irvine's urban forest is thriving and will continue to do so for many generations to come

#### **Community Choice Energy (CCE)**

- 3. Implement food waste recycling at all city facilities



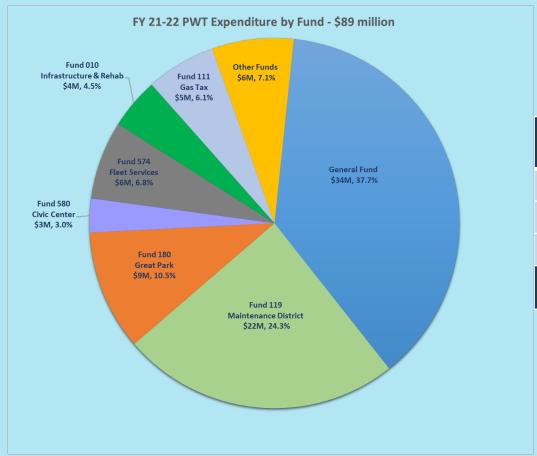

## Major Changes in the FY 2021-23 Budget

\$6 million in contract services dollars to support the city's deferred maintenance program for our facilities as part of the Council's financial commitment to investing in our aging infrastructure.





As a result of the State's minimum wage increase, labor based contracts are expected to rise when they go out to re-bid.
Such as our custodial, landscape and tree trimming contracts. Some could potentially go up by 25%.



### Key Balancing Measures-Two Years

### Notable Balancing measure:

- Contract service savings across all divisions without impacting core services - \$ 2.0 million
  - Landscape Maintenance: Reduced non-critical maintenance work such as seasonal and extra work.
  - Facilities Maintenance: Reduced as-needed and scheduled maintenance services.
- Correctly allocate staff to special funds: \$220,000
  - Allocation of personnel managing the Great Park
- Reduced supplies, overtime, and business expense across all divisions:
   \$108,000







# Landscape, Lighting and Park Maintenance (LLPM)

LLPM is a special district formed to pay for ENHANCED landscaping and related or connected improvements, maintenance, and services.

### **LLPM Supports:**

- Landscape maintenance efforts for community and neighborhood parks
- Facility maintenance for community centers and park amenities
- Streetlights and signalized intersection utility and maintenance costs

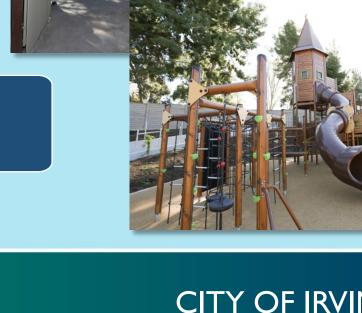
