

AMENDMENT NUMBER 1 TO "AGREEMENT FOR CONTRACT SERVICES"

THIS AMENDMENT NUMBER 1 TO AGREEMENT FOR CONTRACT SERVICES (the "First Amendment") is made and entered into as of October 03, 2023 by and between the CITY OF IRVINE, a municipal corporation ("City") and PATROL SOLUTIONS, LLC, a California limited liability company ("Contractor"), for the purpose of amending the written "Agreement for Contract Services" entered into between City and Contractor as of September 19, 2022, City of Irvine contract number 20635 (the "Agreement").

1. The expiration date of the Agreement is changed from October 31, 2023, to October 31, 2024.

4. Except as set forth in this First Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.
