

AMENDMENT NUMBER 2 TO “AGREEMENT FOR CONTRACT SERVICES”

THIS AMENDMENT NUMBER 2 TO AGREEMENT FOR CONTRACT SERVICES (the "Second Amendment") is made and entered into as of July 01, 2024 by and between the CITY OF IRVINE, a municipal corporation ("City") and WWWT INC., a California corporation ("Contractor"), for the purpose of amending the written "Agreement for Contract Services" entered into between City and Contractor as of March 06, 2023, City of Irvine contract number 20691 (the "Agreement").

1. The expiration date of the Agreement is changed from June 30, 2024 to June 30, 2025.
2. PART V, BUDGET, is modified in accordance with EXHIBIT I, attached hereto. The total contract value remains unchanged for the current renewal term with a not-to-exceed contract value of \$60,000.00.
3. Except as set forth in this Second Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.
