

## **AMENDMENT NUMBER 1 TO “AGREEMENT FOR CONSULTING SERVICES”**

THIS AMENDMENT NUMBER 1 TO AGREEMENT FOR CONSULTING SERVICES (the “First Amendment”) is made and entered into as of June 25, 2024 by and between the CITY OF IRVINE, a municipal corporation (“City”) and UNITED SITE SERVICES OF CALIFORNIA, INC., a California corporation (the “Consultant”), for the purpose of amending the written “Agreement for Consulting Services” entered into between City and Consultant as of June 30, 2023, City of Irvine contract number 20886 (the “Agreement”).

1. The expiration date of the Agreement is changed from June 30, 2024 to June 30, 2025.
2. PART V, BUDGET, is modified to:
  - a. State there is no distinction between City and Great Park budget amounts.
  - b. The contract value remains unchanged for the current renewal period with a total Agreement amount not-to-exceed \$60,000.00.
3. Except as set forth in this One Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.


