

## **AMENDMENT NUMBER 3 TO “AGREEMENT FOR TRADES-RELATED SERVICES”**

THIS AMENDMENT NUMBER 3 TO AGREEMENT FOR TRADES-RELATED SERVICES (the “Third Amendment”) is made and entered into as of June 25, 2024 by and between the CITY OF IRVINE, a municipal corporation (“City”) and SECURITY SIGNAL DEVICES (SSD), a California corporation (“Contractor”), for the purpose of amending the written “Agreement for Trades-Related Services” entered into between City and Contractor as of June 27, 2022, City of Irvine contract number 20298 (the “Agreement”).

1. The expiration date of the Agreement is changed from June 30, 2024 to June 30, 2025.
2. PART IV, SCOPE OF SERVICES, is modified to add new City facilities and reflect changes to services as described below and in accordance with EXHIBIT I.
  - a. Install a new cellular communicator and add a new location and cellular fire alarm monitoring services at 1701 Armstrong.
3. PART V, BUDGET, is modified to:
  - a. State there is no distinction between City and Great Park budget amounts.
  - b. Increase the contract total by \$418.80 in accordance with EXHIBIT I, attached hereto.


The total not-to-exceed contract value, for the current renewal period is increased by \$418.80 from \$135,764.40 to \$136,183.20.

4. Except as set forth in this Third Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.



# SSD Alarm

## SCOPE OF WORK

SSD proposes to provide and install a new cellular communicator to this existing fire alarm system. Panel programming codes should be unlocked or at factory default to avoid any complications. SSD will test the communication path to ensure proper signal transmission. NFPA72 full system testing is excluded. Any obvious defects to this older panel will be brought to your attention.

## INCLUSIONS

- Labor to install system as described in this proposal
- Programming
- Materials as listed in this proposal
- Purchase sales tax

## EXCLUSIONS AND CLARIFICATIONS

- Any devices required by the AHJ, owner or architect that are in addition to those listed in this proposal are subject to a change order
- 120V AC power at main panel and any remote power supplies
- All trench and underground conduit provided by others
- Plan check and permit fees
- Knox box provided and installed by others if required
- Any patching, painting, replacement of ceiling tiles, wall covering repair is excluded
- Itemized list of equipment and scope of work with Inclusions and Exclusions must appear on install contract
- Engineering fees for shop drawings and submittals
- Fire rated backboard for panels to be supplied and installed by others
- Union or prevailing wage is not included. If required, additional cost will apply.
- Bond fees and bonding
- Any repairs to existing equipment will be done on a time and material basis.
- This proposal is valid for 60 days.
