

AMENDMENT TO “AGREEMENT FOR PROFESSIONAL CONSULTING SERVICES”

THIS AMENDMENT TO AGREEMENT FOR PROFESSIONAL CONSULTING SERVICES is made and entered into as of December 20, 2024 by and between the CITY OF IRVINE, a municipal corporation (“City”) and ANSER ADVISORY MANAGEMENT, LLC, a California limited liability company (“Consultant”), for the purpose of amending the written “Agreement for Professional Consulting Services” entered into between City and Consultant as of March 27, 2024, City of Irvine contract number 21291 (the “Agreement”). Consultant is included on the City of Irvine 2024 On-Call Program List.


1. PART V, BUDGET, is modified to implement FY 24-25 Construction Inspection Services for CFD CIP 311309 Streets and Storm Drains, with a not-to-exceed project contract value of \$600,000.00 for the Scope of Work in accordance with EXHIBIT I, attached hereto.
2. Except as set forth in this Amendment, all terms, conditions, and provisions of the Agreement are unchanged and remain in full force and effect.



Dear Mr. Montoya,

Anser Advisory, Part of Accenture, is pleased to submit this proposal to provide extended Senior Construction Inspection services to assist the City of Irvine. The rates are per our contract dated April 1, 2024 – June 30, 2027 (RFP 24-3394).

The rate for our Senior Construction Inspector will be billed at the new contract rate of **\$180/hr**. Any hours over 40 hours per week or work on Saturday would be billed at **\$234/hr** (overtime rate) and any hours over 12 hours in one shift plus Sundays and Holiday would be **\$288/hr** (double-time rate). The calculation of the hours would be subject to prevailing wage rules as well. Our budget estimate is **\$600,000.00** (approx. 3,333 hours).

Scope of Services

- Consultant shall perform Inspection Services for Community Facilities District CIP 311309 Streets and Storm Drains as set forth below.
- Consultant must Inspect, Track Quantities, and Document on Daily Reports for **all** phases of construction; for Asphalt Paving, Slurry Seal, and Removal and Reconstruction of Pedestrian Access Ramps, Curb & Gutter and Concrete Flat Work & Infrastructure
- Consultant Inspector must be able to **interpret** Construction Plans and Specification, Traffic Control Plans, and Storm Water Pollution Prevention Plans.
