

**AMENDMENT NUMBER 1  
TO “AGREEMENT FOR TRADES-RELATED SERVICES”**

THIS AMENDMENT NUMBER 1 TO AGREEMENT FOR TRADES-RELATED SERVICES (the “First Amendment”) is made and entered into as of February 28, 2025 by and between the CITY OF IRVINE, a municipal corporation (“City”) and SADDLEBACK FENCE AND VINYL PRODUCTS, INC., a California corporation (“Contractor”), for the purpose of amending the written “Agreement for Trades-Related Services” entered into between City and Contractor as of December 19, 2024, City of Irvine contract number 21835 (the “Agreement”).

1. PART V, BUDGET, is modified to increase the not-to-exceed contract value by \$36,990.00 from \$6,990.00 to \$43,980.00 for additional services in accordance with EXHIBIT I, attached hereto.
2. Except as set forth in this First Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.




