

AMENDMENT NUMBER 3 TO “AGREEMENT FOR CONTRACT SERVICES”

THIS AMENDMENT NUMBER 3 TO AGREEMENT FOR CONTRACT SERVICES (the "Third Amendment") is made and entered into as of June 02, 2025 by and between the CITY OF IRVINE, a municipal corporation ("City") and THE CODE GROUP, INC. dba VCA CODE, a California corporation ("Contractor"), for the purpose of amending the written "Agreement for Contract Services" entered into between City and Contractor as of August 12, 2022, City of Irvine contract number 20598 (the "Agreement").


1. The expiration date of the Agreement is changed from June 30, 2025 to June 30, 2026.
2. PART V, BUDGET, remains unchanged for the current renewal term with a not-to-exceed contract value of \$700,000.00.
3. Except as set forth in this Third Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.
