

AMENDMENT NUMBER 4 TO “AGREEMENT FOR TRADES-RELATED SERVICES”

THIS AMENDMENT NUMBER 4 TO AGREEMENT FOR TRADES-RELATED SERVICES (the “Fourth Amendment”) is made and entered into as of June 30, 2025 by and between the CITY OF IRVINE, a municipal corporation (“City”) and EL CAMINO ASPHALT PAVING CORP., a California corporation (“Contractor”), for the purpose of amending the written “Agreement for Trades-Related Services” entered into between City and Contractor as of November 30, 2021, City of Irvine contract number 20180 (the “Agreement”).

1. The expiration date of the Agreement is changed from June 30, 2025 to June 30, 2026.
2. PART III, SPECIAL PROVISIONS, 8. Prevailing Rates of Wages, the last paragraph is replaced in its entirety by the following,

If compliant certified payroll records in accordance with Labor Code Section 1776 are not submitted to City by Contractor, City may withhold final payment until such compliant certified payroll records are provided. The City of Irvine will be using the eComply Solutions software for managing certified payrolls on this project. Accordingly, Contractor shall register in, attend training for, and use the eComply Solutions software for submitting certified payrolls and related tasks as deemed appropriate by the City of Irvine. When this project commences, you will be contacted by an eComply Solutions representative regarding this process. Further information will be provided via a separate communication at that time.

3. PART V, BUDGET, is modified to include a 3% increase to the unit price based on the Consumer Price Index data in accordance with EXHIBIT I, attached hereto. The new not-to-exceed contract value is increased by \$4,305 from \$143,500 to \$147,805.00
3. Except as set forth in this Fourth Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.


