

## **AMENDMENT NUMBER 2 TO “AGREEMENT FOR CONTRACT SERVICES”**

THIS AMENDMENT NUMBER 2 TO AGREEMENT FOR CONTRACT SERVICES (the "Second Amendment") is made and entered into as of June 23, 2025 by and between the CITY OF IRVINE, a municipal corporation ("City") and CULVER CAR WASH, LLC dba CULVER AUTO SPA, a California limited liability company ("Contractor"), for the purpose of amending the written "Agreement for Contract Services" entered into between City and Contractor as of March 09, 2023, City of Irvine contract number 20748 (the "Agreement").

1. The expiration date of the Agreement is changed from June 30, 2025 to June 30, 2026.
2. PART I, FUNDAMENTAL TERMS, D - Party Representatives, D.1., is deleted in its entirety and replaced with the following:

4. Except as set forth in this Second Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.




