AMENDMENT NUMBER 3 TO "AGREEMENT FOR CONSULTING SERVICES"

 - a. For the current term expiring June 30, 2025, the not-to-exceed contract value is increased by \$25,000.00, from \$100,000.00 to \$125,000.00.
 - b. For the renewal term expiring June 30, 2026, the not-to-exceed contract value remains unchanged at \$125,000.00.
- 3. Except as set forth in this Third Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.
