

AMENDMENT NUMBER 4 TO “AGREEMENT FOR TRADES-RELATED SERVICES”

THIS AMENDMENT NUMBER 4 TO AGREEMENT FOR TRADES-RELATED SERVICES (the “Fourth Amendment”) is made and entered into as of November 05, 2024 by and between the CITY OF IRVINE, a municipal corporation (“City”) and QUALITY SPRAYERS, INC., a California corporation (“Contractor”), for the purpose of amending the written “Agreement for Trades-Related Services” entered into between City and Contractor as of November 15, 2021, City of Irvine contract number 20249 (the “Agreement”).

1. The expiration date of the Agreement is changed from October 31, 2025, to October 31, 2026.
2. PART D, Party Representatives, is replaced in its entirety with the following:

3. PART V, BUDGET, is modified to increase the unit price by ten percent (10%) in accordance with EXHIBIT I. The total not-to-exceed contract value for the renewal term is increased by \$7,824.27 from \$78,242.66 to \$86,066.93.
4. Except as set forth in this Fourth Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.
