

**AMENDMENT NUMBER 5
TO “AGREEMENT FOR CONSULTING SERVICES”**

THIS AMENDMENT NUMBER 5 TO AGREEMENT FOR CONSULTING SERVICES (the “Fifth Amendment”) is made and entered into as of December 18, 2025 by and between the CITY OF IRVINE, a municipal corporation (“City”) and ASCENT ENVIRONMENTAL, INC, a California corporation (the “Consultant”), for the purpose of amending the written “Agreement for Consulting Services” entered into between City and Consultant as of July 01, 2021, City of Irvine contract number 20077 (the “Agreement”).

1. The expiration date of the Agreement is changed from January 31, 2026 to January 31, 2027.
2. PART V, BUDGET, remains unchanged with a not-to-exceed contract value of \$878,460.00.
3. Except as set forth in this Fifth Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.
