TO “AGREEMENT FOR TRADES-RELATED SERVICES”**

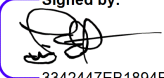

2. Except as set forth in this First Amendment, all terms, conditions and provisions of the Agreement are unchanged and remain in full force and effect.

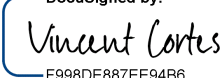
